Dear Chancellor Yoshikawa:

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting June 4-6, 2014, reviewed the Follow-Up Report submitted by Hawai'i Tokai International College and the report of the evaluation team that visited Friday, April 11, 2014.

The Commission took action to **remove Warning and reaffirm accreditation**. Hawai'i Tokai International College provided evidence, and the team verified, that it has addressed and now meets Eligibility Requirement 19 – Institutional Planning and Evaluation, and has addressed Recommendations 1 (on institutional goals), 2 (on evaluation of governance, planning and decision-making structures), 3 (on revision of student learning outcomes), and 5 (on staff development opportunities), resolved the deficiencies, and now meets the Standards associated with these recommendations.

The Follow-Up Report submitted in March 2014 will become part of the accreditation history of the College. The Commission requires that you give the Report, the External Evaluation Report, and this letter appropriate dissemination to your College staff and to those who were signatories of your Follow-Up Report. This group should include the campus leadership and the Board of Regents.

The Commission also requires that the Follow-Up Report, the External Evaluation Report, and this Commission action letter be made available to students and the public by placing a copy on the College website. *Please note that in response to public interest in disclosure, the Commission now requires institutions to post accreditation information on a page no farther than one click from the institution's home page.*

Institutions are expected to meet Eligibility Requirements, Accreditation Standards, and Commission policies at all times during the six-year review cycle. Hawai'i Tokai International College must demonstrate to the Commission at the time of the next regularly scheduled report that the recent changes implemented to resolve deficiencies and meet Eligibility Requirements and Standards have been sustained. Hawai'i Tokai International College will submit a Midterm Report in **spring 2015**.
